Minutes of the regular meeting of the Hobbs City Commission held on Monday, April 6, 2020, in Hobbs, New Mexico. This was a virtual meeting held by video conferencing and viewable to the public via Livestream on the City's website at <u>www.hobbsnm.org</u>.

Call to Order and Roll Call

Mayor Cobb called the virtual meeting to order at 6:00 p.m. and welcomed everyone viewing through Livestream. Mayor Cobb called the roll and the following identified themselves as participating remotely through video conferencing and answered present:

Mayor Sam D. Cobb Commissioner Marshall R. Newman Commissioner Christopher Mills Commissioner Larron B. Fields Commissioner Joseph D. Calderón Commissioner Dwayne Penick Commissioner Don Gerth

The following staff members participated remotely via video conference or appeared at separate times as a presenter in the Commission Chamber:

Mayor Cobb explained the guidelines issued by the New Mexico Attorney General's Office, Open Government Division (OGD), regarding the virtual public body meeting through video conferencing. He stated the following guidelines must be followed:

- At the start of the meeting, the Mayor should announce the names of those members of the public body participating remotely.
- All members of the public body participating remotely must identify themselves whenever they speak and must be clearly audible to the other members of the public body and to the public.
- Members of the public should be afforded remote access, via live stream.
- Mayor should suspend discussion if the audio or video is interrupted.
- All votes of the public body must be a roll call vote.
- The public body should produce and maintain a recording of the open session of the meeting.

**For the record, it is noted that all of these guidelines were strictly followed during the entire City Commission meeting.

Invocation and Pledge of Allegiance

Commissioner Fields delivered the invocation and Mayor Cobb led the Pledge of Allegiance.

Organizational Meeting of the Commission

Selection of Mayor Pro-Tem per Section 5-1 of the Hobbs City Charter.

Mayor Cobb explained the requirement for an organizational meeting of the City Commission and stated pursuant to Section 5-1 of the Hobbs City Charter, the Commission shall elect one of its members to serve as Mayor Pro-Tem.

Mayor Cobb recommended that Commissioner Calderón be nominated to serve as Mayor Pro-Tem.

There being no discussion, Commissioner Newman nominated Commissioner Calderón to serve as Mayor Pro-Tem. Commissioner Mills seconded the motion and there being no other nominations, roll call vote was recorded as follows: Newman yes, Mills yes, Fields yes, Calderón yes, Penick yes, Gerth yes, Cobb yes. The motion carried.

Approval of Minutes

Commissioner Calderón moved that the minutes of the regular meeting held on Monday, March 16, 2020, be approved as presented. Commissioner Newman seconded the motion and the roll call vote was recorded as follows: Mills yes, Fields yes, Newman yes, Calderón yes, Penick yes, Gerth yes, Cobb yes. The motion carried.

There were no proclamations or awards of merit presented to the Commission.

Discussion

There were no items for discussion presented to the Commission.

Action Items

FINAL ADOPTION: Ordinance No.1123 - Amending Chapter 3.20 of the Hobbs Municipal Code Regarding the City of Hobbs' Procurement Policy.

Mr. Toby Spears, Finance Director, stated the City of Hobbs is a Home Rule Charter form of government who enacts its own procurement ordinance. The current procurement ordinance was adopted five years ago. He stated the City needs to update this ordinance to incorporate additionally needed processes and procedures for guidance on procurement. The following is a list of the proposed changes:

• Change thresholds from \$20,000.00 to \$75,000.00 on written quotes, bids, RFPs, NMGSA, CES, HGAC, sole source and emergency contracts

- Adds an exemption section
- Adds an approval of contract section
- Adds language for trade-in's and auction services

Proper publication having been made, and no public comments having been submitted in writing prior to the meeting, and there being no discussion, Commissioner Calderón moved to adopt Ordinance No. 1123 as presented. Commissioner Newman seconded the motion and roll call vote was recorded as follows: Newman yes, Mills yes, Fields yes, Calderón yes, Penick yes, Gerth yes, Cobb yes. The motion carried. A copy of the ordinance is attached and made a part of these minutes.

<u>Resolution No. 6926 – Approving a Lease Assignment for the Hobbs Motorsports Park</u> <u>Facility to Hobbs Airfield Speedway, LLC</u>.

Mr. Kevin Robinson, Development Director, explained the lease assignment and stated a request has been made by the current lessee. Hobbs Motorsports Park Inc., to assign the existing lease to Hobbs Airfield Speedway, LLC. He stated the existing lease was assigned to Hobbs Motorsports Park Inc., on May 21, 2002, per Resolution No. 3742 and covers +/- 100 acres located northwest of the intersection of Millen and Business Park Boulevard. Mr. Robinson stated the existing lease term is 25 years which expires on June 1, 2027, with an option to renew for two additional 25-year terms for a monthly lease of \$150.00. He stated exercising the additional term option does trigger a renegotiation of the lease payments. Mr. Robinson stated currently each lease of publicly owned real property with a market value greater than or equal to \$25,000.00 should be at fair market value, which would increase monthly lease payments upon exercising an additional lease term in seven years. He stated the lease would be \$150.00 per month which is \$1,800.00 per year for the remaining seven years of the primary term. Mr. Robinson stated GASB 87 requires for leases to be disclosed in an estimated asset value on June 30, 2020. This lease will be reassessed at the end of lease term through a possible appraisal of the asset. The City may implement this standard prior to 2021. Mr. Robinson stated this lease assignment is in compliance with the anti-donation law and lease payments will be reevaluated at the time of the lease renewal.

In answer to Commissioner Newman's question, Mr. Robinson stated this is not a new lease but an assignment of the existing lease. There being no further discussion, Commissioner Gerth moved that Resolution No. 6926 be approved as submitted. Commissioner Penick seconded the motion and roll call vote was recorded as follows: Newman yes, Mills yes, Fields yes, Calderon yes, Penick yes, Gerth yes, Cobb yes. The motion carried. Copies of the resolution and supporting documents are attached and made a part of these minutes.

<u>Resolution No. 6927 – Approving an Amendment to the Development Agreement</u> with Suerte Land Group, LLC, Concerning the Projection of the Suerte Drive South of the Exiting Terminus Date April 1, 2019.

Mr. Robinson stated the City Commission approved a development agreement with Suerte Land Group, LLC (Developer) on April 1, 2019, concerning the fair share development of the southerly projection of Suerte Drive. He stated the development agreement allowed for the fair share reimbursement of the infrastructure costs or \$350,000.00, whichever is less, providing infrastructure is installed and reimbursement occurs 365 days from ratification of the development agreement which was March 31, 2020. Mr. Robinson stated the Developer has requested that the development agreement be extended to January 1, 2021. He stated all other terms of the development agreement will remain unchanged.

There being no discussion, Commissioner Gerth moved that Resolution No. 6927 be approved as submitted. Commissioner Newman seconded the motion and the roll call vote was recorded as follows: Newman yes, Mills yes, Fields yes, Calderon yes, Penick yes, Gerth yes, Cobb yes. The motion carried. A copy of the resolution is attached and made a part of these minutes.

<u>Consideration of Approval of Bid No. 1577-20 to Furnish Labor and Parts for Pump</u> <u>Repair and Recommendation to Award Bid to WHB Pump Sales, LLC, of Lovington,</u> <u>New Mexico, in an Indefinite Quantity Amount</u>.

Mr. Tim Woomer, Utilities Director, explained the Bid No. 1577-20 and stated formal bids were opened at 2:00 p.m., on Tuesday, March 10, 2020, to furnish the City of Hobbs with labor, equipment, machine work, and parts for the repair, replacement, and installation of pumps and pump motors for the City of Hobbs water production wells and booster pump stations operating within the City's water production system. He stated one qualified bid was submitted by WHB Pump Sales, LLC. Mr. Woomer stated the bid is in the amount of \$10,600.00, excluding NMGRT, for this indefinite quantity contract and staff recommends accepting the bid.

There being no discussion, Commissioner Calderón moved to accept Bid No. 1577-20 from WHB Pump Sales, LLC, as described. Commissioner Fields seconded the motion and roll call vote was recorded as follows: Mills yes, Newman yes, Fields yes, Calderón yes, Penick yes, Gerth yes, Cobb yes. The motion carried. A copy of the supporting documentation is attached and made a part of these minutes.

Acting City Manager/Fire Chief Gomez stated there are 40 viewers on Livestream for tonight's Commission meeting.

Mayor Cobb encouraged everyone to fill out the 2020 Census forms and stressed the importance of being counted.





Summary:

The Hobbs Fire Department wishes to purchase a 2020 Type I Medix Ambulance utilizing a HGAC contract. The purchase of this ambulance would replace a 2014 G4500 Type III Ambulance which is currently out of service due to damage suffered while returning back to Hobbs from Lubbock, TX after completing a nonemergency transport. With the damage suffered by the ambulance, coupled with its high mileage, it was determined there is no cost benefit to have the unit repaired.

The 2020 Type I Medix Ambulance would be placed into service as a front line response unit, allowing the department to transition an older unit into the non-emergency transport cycle. The department currently has 6 ambulances in its fleet, not counting the one which is out of service, and this purchase would allow us to maintain 7 ambulances in operation for our community.

The total cost for purchasing the ambulance is \$217,524.00. There is currently \$155,000 budgeted for this purchase in 001-0220-43014 (Public Safety Equipment). A reclassification of funds in the amount of \$65,000 would be necessary from 001-0220-43003 (Vehicle Replacement) to 001-0220-43014 (Public Safety Equipment) in order to fully fund this purchase.

- 2 Installation of Fence.
