Minutes of the regular meeting of the Hobbs City Commission held on Monday, November 2, 2020, in Hobbs, New Mexico. This was a virtual meeting held by video conferencing and viewable to the public via Livestream on the City's website at www.hobbsnm.org.

Call to Order and Roll Call

Mayor Cobb called the meeting to order at 6:00 p.m. and welcomed everyone viewing through Livestream. Mayor Cobb called the roll and the following identified themselves as participating remotely through video conferencing and answered present:

Mayor Cobb explained the guidelines issued by the New Mexico Attorney General's Office, Open Government Division (OGD), regarding the virtual public body meeting through video conferencing. He stated the following guidelines must be followed:

- At the start of the meeting, the Mayor should announce the names of those members of the public body participating remotely.
- All members of the public body participating remotely must identify themselves whenever they speak and must be clearly audible to the other members of the public body and to the public.
- Members of the public should be afforded remote access, via livestream.
- Mayor should suspend discussion if the audio or video is interrupted.
- All votes of the public body must be a roll call vote.

• The public body should produce and maintain a recording of the open session of the meeting.

For the record, it is noted that all of these guidelines were strictly followed during the entire City Commission meeting.

Invocation and Pledge of Allegiance

Commissioner Penick delivered the invocation and Commissioner Gerth led the Pledge of Allegiance.

Approval of Minutes

Proclamations and Awards of Merit

Proclamation Proclaiming November 8-14, 2020, as "National Nurse Practitioner Week".

Mayor Cobb proclaimed November 8 - 14, 2020, as *"National Nurse Practitioner Week"*, and he recognized Ms. Shawnna Read-Richards, who accepted the proclamation on behalf of the Lea County Nurse Practitioners. Ms. Read-Richards stated there are 48 nurse practitioners in the local group and these nurse practitioners are at the front lines of the pandemic and play a key role in actively fighting COVID-19. She thanked the Mayor and Commission for recognizing nurse practitioners nationwide.

Commissioner Calderón stated nurse practitioners do a super job taking care of people. He thanked Ms. Read-Richards for all they do in the medical field.

Discussion

Drainage Master Plan for Rockwind Community Links.

Mr. Bryan Wagner, Parks and Open Spaces Director, introduced Mr. Zachary Boudreaux, of Turf Drain of America, who presented a PowerPoint presentation to the Commission regarding a Drainage Master Plan for Rockwind Community Links. He made some suggestions to the Commission for possible solutions to the turf areas at the golf course which are bald. He stated most turf issues of this nature are related to drainage and no place for water to go. He suggested that a seepage collection system is needed, and he stated some of the transportation options available to move the seepage are gravity, siphon, pump or a combination of these options. One of the methods discussed was an irrigation driven pump and pumping the sediment into the lake to recycle the water.

In response to Commissioner Gerth's question, Mr. Boudreaux stated the nearest golf course that has utilized Turf Drain of America is located in Scottsdale, Arizona. He stated results would be visible but he is hesitant to give a timeframe for when a difference would be noticed as all golf courses respond differently.

After a brief discussion regarding filtering of the sediment, Mayor Cobb requested Mr. Boudreaux follow up with the Commission regarding how much sediment could possibly build up in the lake per year.

Recognition of the Hobbs Hispano Chamber of Commerce.

Acting City Manager/Fire Chief Manny Gomez introduced Ms. Susana Arvizu, President of the Hobbs Hispano Chamber of Commerce (Chamber). He stated Commissioner Calderón requested the youth group with the Chamber be recognized for their participation in the recent District 3 City of Hobbs Clean-Up. Ms. Arvizu thanked the Commission for allowing her to recognize Activate. She stated the group started out as a church group and have now expanded to assist the entire community. Ms. Arvizu stated she asked for four volunteers and 15 volunteers, all high school and college students, from Activate assisted in the City of Hobbs Clean-Up. She thanked the group and the Hobbs Fire Department for their participation in this community effort.

Commissioner Calderón stated he also participated in the District 3 Clean-Up and it was good to meet this group.

Action Items

Resolution No. 6991 – Approving the FY 2021 DFA 1st Quarter Financial Report.

Mr. Toby Spears, Finance Director, presented a PowerPoint presentation to the Commission reviewing the DFA 1st Quarter Financial Report for FY 2021. He stated the total year-to-date expenditures are \$26,441,352.04 and total year-to-date revenues are \$25,159,491.12. Mr. Spears stated the ending cash balance for September 30, 2020, is \$146,399,061.12 for all funds.

There being no discussion, Commissioner Calderón moved that Resolution No. 6991 be adopted as presented. Commissioner Penick seconded the motion and roll call vote was recorded as follows: Newman yes, Mills yes, Fields yes, Calderón yes, Penick yes, Gerth yes, Cobb yes. The motion carried. Copies of the resolution and supporting documents are attached and made a part of these minutes.

Resolution No. 6992 – Adopting Budgetary Adjustment #2 for FY 2020-2021.

Mr. Spears presented a PowerPoint to the Commission regarding the Budgetary Adjustment #2 for FY 2020-2021. He stated the annual budget is prepared prior to the beginning of the fiscal year and it becomes necessary to adjust the budget for items not contemplated at the time of its preparation, or for issues that arise during the fiscal year. Mr. Spears stated the total revenues decreased by \$432,615.29, and the total expenditures increased by \$365,243.97 providing an ending balance of \$86,539,994.36 for all funds and a general fund reserve of 46%. He further stated that once approved by the Commission, the resolution must be forwarded to the Department of Finance and Administration for its approval.

Commissioner Gerth moved to approve Resolution No. 6992 as presented. Commissioner Mills seconded the motion and roll call vote was recorded as follows: Newman yes, Mills yes, Fields yes, Calderón yes, Gerth yes, Penick yes, Cobb yes. The motion carried. <u>Resolution No. 6993 – Authorizing Grant Funding for Certain Additional Small Businesses</u> Pursuant to the CARES Act Relief Funds Small Business Continuity Grants.

Mr. Spears stated the City of Hobbs was awarded a Federal CARES Act Relief Funds Small Business Continuity Grant in the amount of \$658,969.00. He stated the New Mexico Department of Finance and Administration (DFA) has oversight on this overall grant and has provided a recommended process as well as procedure guidelines to municipal governments. Mr. Spears further stated the City established an application process for small businesses headquartered in Hobbs, New Mexico. He stated on September 21, 2020, the City Commission approved Resolution No. 6973, which approved the application process for the Grant. Pursuant to that process, the small businesses identified in "Exhibit A" have successfully submitted an application for grant funding. Mr. Spears stated the approval of this resolution would authorize the Finance Department to encumber those funds from the balance of the grant funds and begin the reimbursement process to the businesses. He stated the City has received 67 applications of which 22 have been previously approved, and staff is working with other applicants to submit all of the required documentation. Mr. Spears stated DFA has updated the requirements to apply for the Federal CARES Act Relief Funds Small Business Continuity Grant. He explained the new updates. Mr. Spears also stated each approved applicant will receive funding up to \$5,000.00 and may apply for additional funds of up to \$20,000.00. He stated the funding is strictly for reimbursement and cannot be given as the result of loss of business income. Mr. Spears added businesses cannot seek reimbursement of the same expenses if they were reimbursed through a PPP loan or other source of funding from the Federal Government.

In response to Commissioner Gerth's inquiry, Mr. Spears stated it is best for businesses to submit their applications online and communicate via email. He stated the last day to submit applications is December 4, 2020. He further stated once all of the qualifying documents have been received, the business will not have to resubmit tax documents for its second requests.

There being no further comment or discussion, Commissioner Gerth moved that Resolution No. 6993 be adopted as presented. Mr. Efren Cortez, City Attorney, was appointed as the Hearing Officer. Ms. Linda L. Akins and Mr. Marvin Green, representing BW Gas & Convenience Retail, LLC, d/b/a Allsup's, were present viturally.

Ms. Jan Fletcher, City Clerk, administered the oath to Ms. Akins and Mr. Green as the representatives for BW Gas & Convenience Retail, LLC, d/b/a Allsup's. Ms. Aikins stated she would be presenting testimony as the attorney for the applicant.

Ms. Akins presented testimony in the hearing regarding the application of transfer of ownership and of Liquor Licenses No. 0414 located at 2810 Lovington Highway, No. 0806 located at 4308 North Grimes, No. 0394 located at 316 North Marland, No. 0036 located at 100 East Marland, No. 1058 located at 3709 North Dal Paso and No. 0885 located at 5312 Lovington Highway to BW Gas & Convenience Retail, LLC, d/b/a Allsup's.

In response to Mr. Cortez' inquiry, no members of the public submitted a written response in favor or against the transfers via email to the City Clerk at **<u>ifletcher@hobbsnm.org</u>** or fax to (575) 397-9334 no later than 4:30 p.m. on November 2, 2020.

Mr. Cortez stated the State of New Mexico Alcoholic Beverage Control has granted preliminary approval to the application for transfer of ownership of the liquor licenses and a public hearing has to be held within 45 days of receipt of the application on whether or not the proposed transfer of ownership of the licenses should be granted. He further stated the application can be denied for only three reasons which are as follows: (1) if the location is within 300 feet of a church or school, which is not applicable here; (2) if it is in violation of a zoning or other ordinance of the governing body, which is not applicable here; and (3) if the issuance would be detrimental to the public health, safety or morals of the residents of the local option district.

Ms. Akins testified that all the above statements made by Mr. Cortez are true and correct to her knowledge.

There being no discussion or further comments, Commissioner Calderón moved that Resolutions No. 6994, 6995, 6996, 6997, 6998 and 6999 be adopted approving the transfer of ownership of the liquor licenses listed above from Allsup's to BW Gas & Convenience Retail, LLC. Commissioner Newman seconded the motion and roll call vote was recorded as follows: Newman yes, Mills yes, Calderón yes, Fields yes, Gerth yes, Penick yes, Cobb yes. The motion carried. <u>Resolution No. 7000 – Approving the Final Plan for Kass Glorietta Subdivision Located</u> <u>Northeast of the Intersection of Glorietta and Dal Paso</u>.

Mr. Kevin Robinson, Development Director, stated the Final Plan for Kass Glorietta Subdivision was submitted by Property Management Plus, LLC. He stated the proposed subdivision is located northeast of the intersection of Glorietta and Dal Paso within the

<u>Resolution No. 7001 – Approving the Final Plan for Zia Crossing Subdivision, Phase 2,</u> <u>Unit 7, Located Southwest of Millen Drive and Zia Crossing Parkway</u>.

Mr. Robinson stated the Final Plan for Zia Crossing Subdivision, Phase 2, Unit 7, was submitted by Black Gold Estates, LLC. He stated the proposed subdivision is located southwest of the intersection of Millen Drive and Zia Crossing Parkway within the municipal boundaries. Mr. Robinson stated the proposed subdivision encompasses +/-25.73 acres and will contain 99 single family residential lots. He stated the City of Hobbs Planning Board approved the Final Plans for this subdivision on October 20, 2020, pending an unqualified Engineer of Record Certification (EOR) of Public Infrastructure. Mr. Robinson stated the City is in receipt of an EOR concerning the installation of infrastructure as to the approved construction plan set.

In reply to Commissioner Gerth's question, Mr. Robinson stated a park will be included in the Master Plan by Black Gold Estates, LLC. He stated the park has been relocated to an west of the units in order for everyone to have access to the park.

Commissioner Fields moved that Resolution No. 7001 be adopted as presented. Commissioner Calderón seconded the motion and roll call vote was recorded as follows: Newman yes, Mills yes, Fields yes, Calderón yes, Penick yes, Gerth yes, Cobb yes. The motion carried. FINAL ADOPTION: Ordinance No. 1127 - Approving a Real Estate Purchase Agreement to Sell and Convey Real Property Located at 3425 North Northwest to Troy Hudson and Melissa Hudson for the Purchase Price of \$155,000.00.

Mr. Robinson explained the ordinance and stated the City proposes to sell and convey real property located at 3425 North Northwest, Hobbs, New Mexico, to Troy and Melissa Hudson for the purchase price of \$155,000.00. Mr. Robinson stated the most recent appraisal conducted on this property in June of 2018 reflected a fair market value at \$158,000.00. He stated the Real Estate Purchase Agreement (REPA) provides for a 6% commission to be paid to the realtor at closing resulting in a net revenue to the City in the amount of \$145,700.00.

Proper publication having been made, and there being no public comments having been submitted in writing prior to the meeting by email or fax and there being no further discussion, Commissioner Penick moved to adopt Ordinance No. 1127 as presented. Commissioner Newman seconded the motion and roll call vote was recorded as follows: Newman yes, Mills yes, Fields yes, Calderón yes, Penick yes, Gerth yes, Cobb yes. The motion carried. A copy of the ordinance is attached and made a part of these minutes.

<u>PUBLICATION: Proposed Ordinance Amending Chapter 2.60 of the Hobbs Municipal</u> <u>Code Related to Labor Management Relations</u>.

Mr. Cortez stated during the 2020 Regular Legislative Session, the New Mexico Legislature passed House Bill 364 (HB 364) which amended the Public Employees Bargaining Act (NMSA 1978, § 10-7E-1, et seq.). He stated on March 5, 2020, Governor Michelle Lujan Grisham signed HB 364 into law. Part of HB 364 required local governments to submit to the State Public Employees Labor Relations Board (PELRB) copies of updated local ordinances that reflect the changes required by HB 364. The PELRB has approved a model ordinance. Mr. Cortez the Legal Department has prepared a proposed ordinance for the City of Hobbs which substantially complies with the approved model ordinance. Mr. Cortez stated failure to adopt a local ordinance that substantially complies with the model ordinance may result in the local government losing its local Labor Board. He further stated time is of the essence for the Commission to submit a final adopted ordinance to the State by December 31, 2020.

There being no discussion, Commissioner Gerth moved to publish notice of its intent to adopt the ordinance at a later date. Commissioner Newman seconded the motion and roll call vote was recorded as follows: Newman yes, Mills yes, Fields yes, Calderón yes, Penick yes, Gerth yes, Cobb yes. The motion carried. Copies of the proposed ordinance and supporting documentation are attached and made a part of these minutes.

<u>Resolution No. 7002 – Approving Renewals of Medical, Benefit Value Advisor, Dental,</u> <u>Vision, Teladoc, Life Insurance, Short Term Disability, Long Term Disability, Critical</u> <u>Illness Coverage, Hospital Indemnity Coverage and Accident Coverage</u>.

Mr. Nicholas Goulet, Human Resources Director, introduced Ms. Charlene Fairchild, a representative from AON. Ms. Fairchild and Mr. Goulet presented a PowerPoint presentation to the Commission reviewing the Medical/Blue Cross/Blue Shield (BCBS) employee ratios. Benefit Value Advisor/BCBS. Dental/Delta Dental. Telemedicine/TelaDoc, VSP/Vision Insurance, Short Term Disability/Hartford, Long Term Disability/Hartford, Life Insurance/Hartford, Critical Illness/Hartford, Group Accident Insurance Plan/Hartford and the FSA Flexible Spending Account for City Employees. He stated the City anticipates an increase of 6.7% in cost for FY 2021 for coverage in relation to the current rates paid in calendar year 2020. Mr. Goulet stated AON received bids from BCBS (current provider), United Healthcare and Presbyterian and based on the proposed market, he stated BCBS continues to have the lowest overall verified cost and the most comprehensive provider network for our area. Mr. Goulet stated the total renewal

cost for both active employees and retirees is approximately \$8,303,123. He reviewed the various premium costs for City employees based upon the new renewal price.

Commissioner Mills thanked Mr. Goulet for the clear explanation and presentation regarding health care.

There being no further discussion, Commissioner Calderón moved to approve Resolution No. 7002 as presented. Commissioner Newman seconded the motion and roll call vote was recorded as follows: Newman yes, Mills yes, Fields yes, Calderón yes, Penick yes, Gerth yes, Cobb yes. The motion carried. Copies of the resolution and supporting documentation are attached and made a part of these minutes.

Comments by City Commissioners, City Manager

Acting City Manager/Fire Chief Gomez stated the City of Hobbs will be hosting a trash clean-up in District 4 on Saturday, November 21, beginning at 8:00 a.m., in the parking lot at McBride's Supply, 709 W Broadway.

Acting City Manager/Fire Chief Gomez stated the Water Office was forced to close recently. He stated employees everywhere are faced with exposure to COVID-19 and in order to protect employees and citizens, the City may have to close or curtail some operations. Under law, he explained that employee medical information is confidential, and he requested that the public be patient if and when a closure occurs.

Commissioner Fields stated he is thankful to have recently attended a virtual Municipal Office Leadership Institute (MOLI) training hosted by the New Mexico Municipal League that was very informative and beneficial to him. Commissioner Fields thanked Ms. Mollie Maldonado, Deputy City Clerk, for her assistance in getting him enrolled in the virtual program.

Commissioner Fields expressed his appreciation to Ms. Tanya Sanchez, Tourism Coordinator, the Hobbs Fire Department and the volunteers from the Hobbs Hispano Chamber of Commerce for their assistance during the District 3 Clean-Up. He stated there was 2,200 pounds of trash picked up.

Commissioner Calderón announced the the District 4 Clean-Up has been scheduled for Saturday, November 21, 2020. He stated the Clean-Up will begin at the corner of Grimes and Broadway at 8:00 a.m. He added that anyone wanting more information could contact Ms. Sanchez at 575-391-4178. Commissioner Calderón encouraged everyone to remember social distancing, wear a mask and wash hands frequently.

Commissioner Penick thanked everyone for the hard work put on tonight's PowerPoint presentations. He also expressed his appreciation to the military and first responders.

Commissioner Penick reminded everyone to exercise their right to vote at the 2020 General Election to be held on November 3, 2020.

Commissioner Penick stated 2020 is the second year he has worked on the Clean-Up of District 5, and he appreciates the other Commissioners following suit.

Commissioner Gerth expressed his appreciation to everyone for their hard work.

Mayor Cobb also encouraged everyone to get out and vote as it is important to the Nation and the State.

<u>Adjournment</u>

Ms. Fletcher:

I am responding to the recent article in the Hobbs News-Sun regarding the enforcement of fireworks in our city. I believe we already have ordinances that address the types of "legal" fireworks in Hobbs, and also the "legal" permissible times to discharge them. The article didn't explain in detail how the existing ordinances are to be changed. Enforcement of the existing ordinances would probably be enough as written, except we need a zero tolerance policy and higher fines and sentences. Confiscation of the illegal fireworks should be included. Zero tolerance! My wife and I have lived in the Taylor Estates for over thirty years and the problems have gotten worse over the entire time. We credit the lack of enforcement for the deterioration. Besides the disobedience around the permissible holidays, there are some people that set them off throughout the year (as recently as two weeks ago at 10:00 PM).

Fireworks are "seasonal". However, an even bigger problem for the entire city is the recreational use of ATV's inside the city limits. Over the past ten years, we have seen these three and four wheelers all over the city. Residential streets and alleys as well as our main streets. We've seen young children less than 5 years old up to adults over 60 years old riding these illegal vehicles. New Mexico has a traffic code that specifically addresses the use of these "off road" vehicles, yet we continue to see them throughout the day and into the night. Some of them have mufflers, but most of them don't. We have witnessed parents driving and carrying their infant children in their laps. Many of these offenders disobey the rules of the road like speeding and ignoring stop/vield signs. Also, we have seen minor children (under 12 years old) driving golf carts on the streets, and ignoring the traffic laws. As with the fireworks problem, enforcement of the current ordinances would go a long ways with a zero tolerance policy. Do the crime, pay the fine. I have called HPD many times over the last ten years and officers have been dispatched almost every time. Most of the time, they have only given the offenders a verbal warning. Would you like to hear how many times they wait until the officer is out of sight, and then return to their "rights" to break the law? I have reported several of the offenders more than once, so that tells me that the verbal warnings are ignored. Almost every day, we have several of the illegal vehicles running thru our streets and alleys. A patrol thru the area every half hour would discourage them if they knew they are going to be cited, and have to pay a sizeable fine.

The primary reasons for the above mentioned ordinances are safety, and preventing public nuisances. By responding to my requests, a tragedy (death or critical injuries) may be avoided by stopping these illegal activities. Few of the children driving or riding on the ATV's are wearing the required safety helmets mandated in the NM Traffic code. Another serious violation we have observed is more than one person on a vehicle designed for only one. One parent that lives near us carries as many as four on his, and he is the only person riding on a seat. His passengers are hanging on! I would recommend at least a \$500 fine for that offense alone, plus the three kids not wearing safety helmets should be a \$100 fine each. I think that is child endangerment. One traffic stop by a police officer should bring his reckless lack of parental thinking to a halt. Maybe even a call to Child Protective Services would be in order, and get them involved.

If any of the city commissioners, the mayor, or the police chief would like to visit with me about our problems, I will be happy to talk to them. You now have my email address and they can contact me at their convenience. We are not on any social media, we prefer to communicate with people we are familiar with. So, please send us an email.

Minutes of the special meeting of the Hobbs City Commission held on Monday, November 9, 2020, in Hobbs, New Mexico. This was a virtual meeting held by video conferencing and viewable to the public via Livestream on the City's website at www.hobbsnm.org.

Call to Order and Roll Call

Mayor Pro Tem Calderón called the meeting to order at 4:00 p.m. and welcomed everyone viewing through Livestream. Mayor Pro Tem Calderón called the roll and the following identified themselves as participating remotely through video conferencing and answered present:

Mr. Efren Cortez, City Attorney, explained the guidelines issued by the New Mexico Attorney General's Office, Open Government Division (OGD), regarding the virtual public body meeting through video conferencing. He stated the following guidelines must be followed:

- At the start of the meeting, the Chair should announce the names of those members of the public body participating remotely.
- All members of the public body participating remotely must identify themselves whenever they speak and must be clearly audible to the other members of the public body and to the public.

- All votes of the public body must be a roll call vote.

Action Items

<u>Resolution No. 7003 – Authorizing Grant Funding for Certain Additional Small Businesses</u> <u>Pursuant to the CARES Act Relief Funds Small Business Continuity Grants</u>.

Mr. Toby Spears, Finance Director, explained the City of Hobbs was awarded a Federal CARES Act Relief Funds Small Business Continuity Grant in the amount of \$658,969.00. He stated the New Mexico Department of Finance and Administration (DFA) has oversight on this overall grant and has provided a recommended process as well as procedure guidelines to municipal governments. The City has established an application process for small businesses headquartered in Hobbs, New Mexico. On September 21, 2020, the City Commission approved Resolution No. 6973, which approved the application process for the Grant. Pursuant to that process, the small businesses identified in "Exhibit A" have successfully submitted an application for grant funding. Mr. Spears stated the approval of this resolution would authorize the Finance Department to encumber those funds from the balance of the grant funds and begin the reimbursement process to these businesses. He stated the City has received 82 applications of which 47 have been previously approved. Mr. Spears stated 20 applicants have qualified for today's special meeting as follows:

Mr. Spears stated each approved new applicant will receive funding up to \$5,000.00 and may apply for additional funds of up to \$20,000.00. He stated the funding is strictly for reimbursement and cannot be given as the result of a loss of business income.

In reply to Commissioner Fields' question, Mr. Spears stated 32 reimbursements have been submitted to DFA thus far in the amount of \$160,000.00. Mr. Spears stated if this resolution is approved today, there will be an additional \$100,000.00 encumbered for a total of \$260,000.00 which is almost 50% of the grant funding for the CARES Act Relief Funds Small Business Continuity Grants in the amount of \$658,969.00.

Commissioner Fields expressed his appreciation to the Finance Department for processing the grant funding as it is a tedious process.

There being no further comment or discussion, Commissioner Newman moved that Resolution No. 7003 be adopted as presented. Commissioner Gerth seconded the motion and roll call vote was recorded as follows: Newman yes, Mills yes, Fields yes, Penick yes, Gerth yes, Calderón yes. The motion carried. Copies of the resolution and supporting documentation are attached and made a part of these minutes.

Comments by City Commissioners, City Manager

Acting City Manager/Fire Chief Manny Gomez thanked everyone for attending today's special meeting. He stated businesses are very critical to the community and the deadline for grant funding for small business is nearing an end. The deadline to apply for the CARES Act Relief Funds Small Business Continuity Grants is December 4, 2020. Acting City Manager/Fire Chief Gomez stated grant funding for small businesses has been advertised in the newspaper, social media and on the City of Hobbs' webpage. He encouraged all small businesses to participate in the grant funding.





AN ORDINANCE AMENDING HOBBS MUNICIPAL CODE CHAPTER 8.12 FIREWORKS

WHEREAS, pursuant to NMSA § 60-2C-7 of the Fireworks Licensing and Safety Act, a municipality may adopt an ordinance regulating certain types of fireworks; and WHEREAS, the City has adopted Chapter 8.12 Fireworks which was last revised in 2001 to comply with the State's Fireworks Licensing and Safety Act; and

WHEREAS, the City wishes to amend Chapter 8.12 to comply with certain changes implemented to the Fireworks Licensing and Safety Act enacted by the New

Mexico Legislature in 2007, as well as certain changes to address concerns that are

unique to local conditions in Hobbs, New Mexico; and

WHEREAS, the amendments contemplated herein will allow the City of Hobbs to address fireworks use and misuse within the municipal boundaries of Hobbs, New Mexico, in a more effective and efficient manner thus protecting the health, safety, and welfare of the general public; and

NOW, THEREFORE, BE IT ORDAINED by the governing body of the City of Hobbs that the Hobbs Municipal Code Chapter 8.12 be amended as follows: Chapter 8.12 - FIREWORKS

8.12.010 - Title for citation.

This chapter shall be known and cited as the "Hobbs fireworks ordinance."

(Prior code § 10A-1)

8.12.020 - Definitions.

As used in this chapter:

<u>"1.3G Explosives" means those items formerly known as Class B special fireworks.</u> Items classified as 1.3G explosives are display fireworks.

<u>"1.4G Explosives" means those items formerly known as Class C common</u> <u>fireworks. Items classified as 1.4G explosives are consumer fireworks intended for use</u> <u>by the general public.</u>

"Aerial device" means a fireworks device that upon ignition propels itself or an insert a significant distance into the air, but does not include a firework that produces a shower of sparks. Aerial device includes sky rocket and bottle rocket, missile-type rocket, helicopter, aerial spinner, Roman candle, mine and <u>aerial</u> shell.

<u>"Aerial shell" means a cylindrical or spherical cartridge containing a lift charge, burst</u> <u>charge and effect composition. Upon firing from a reloadable tube, the lift charge is</u> <u>consumed and the cartridge is expelled into the air.</u>

<u>"Aerial shell kit-reloadable tube" means a package or kit containing a cardboard,</u> <u>high-density polyethylene or equivalent launching tube and not more than twelve small</u> <u>aerial shells. Each aerial shell is limited to a maximum of sixty grams of total chemical</u> <u>composition, including lift charges, and the maximum diameter of each shell shall not</u> <u>exceed one and three-fourths inches.</u>

<u>"Chaser" means a paper or cardboard tube venting out the fuse end of the tube that</u> <u>contains no more than twenty grams of chemical composition and travels along the</u> <u>ground, often producing a whistling effect or other noise; an explosive composition not</u> <u>to exceed fifty milligrams may be included to produce a report.</u>

"City Commission" means the Hobbs City Commission.

"Cone fountain" means a cardboard or heavy paper cone containing no more than fifty grams of pyrotechnic composition that has the same effect as a cylindrical fountain. When more than one cone is mounted on a common base, total pyrotechnic composition shall not exceed two hundred grams.

<u>"Consumer fireworks" also known as 1.4G fireworks, are defined as any small</u> firework device designed to produce visible effects by combustion and which must comply with the construction, chemical composition and labeling regulations of the U.S. Consumer Product Safety Commission. Consumer fireworks are generally marked with brightly colored and decorated paper and include, in part, a trade name and manufacturing information. The Department of Transportation classifies consumer fireworks as UN0336, UN0337.

<u>"Crackling device" means a sphere or paper tube that contains no more than twenty</u> <u>grams of pyrotechnic composition that produces a flash of light and a mild, audible</u> <u>crackling effect upon ignition, which effect is not considered to be an explosion.</u> <u>Crackling devices are not subject to the fifty-milligram limit of firecrackers.</u>

"Cylindrical fountain" means a cylindrical tube containing not more than seventy-five grams of pyrotechnic composition that produces a shower of colored sparks and sometimes a whistling effect or smoke. The device may be provided with a spike for insertion into the ground or a wood or plastic base for placing on the ground or a wood or cardboard handle to be hand held. When more than one tube is mounted on a common base, total pyrotechnic composition shall not exceed two hundred grams.

"Display distributor" means any person, firm or corporation selling special fireworks.

"Display fireworks" means devices primarily intended for commercial displays that are designed to produce visible or audible effects by combustion, deflagration or detonation, including salutes containing more than one hundred thirty milligrams of explosive composition; aerial shells containing more than forty grams of chemical composition exclusive of lift charge; and other exhibition display items that exceed the limits for permissible fireworks.

"Distributor" means any person, firm or corporation selling fireworks to wholesalers and retailers for resale.

"Fire Chief" means the Chief of the Hobbs Fire Department.

<u>"Firecracker" means a small, paper-wrapped or cardboard tube containing no more</u> than fifty milligrams of explosive composition that produces noise and a flash of light; provided that firecrackers used in aerial devices may contain up to one hundred thirty milligrams of explosive composition per report.

<u>"Fireworks" means devices intended to produce a visible or audible effect by</u> <u>combustion, deflagration or detonation and are categorized as "permissible fireworks" or</u> <u>"display fireworks", but does not include novelties or theatrical pyrotechnics articles.</u>

<u>"Flitter sparkler" means a narrow paper tube attached to a stick or wire and filled</u> with no more than five grams of pyrotechnic composition that produces color and sparks upon ignition and the paper at one end of the tube is ignited to make the device function.

"Ground audible device" means a fireworks device intended to function on the ground that produces an audible effect.

"Ground spinner" means a small, rapidly spinning device containing no more than twenty grams of pyrotechnic composition venting out an orifice usually on the side of the tube that when ignited produces a shower of sparks and color. "Ground spinner" is similar in operation to a wheel, but is intended to be placed flat on the ground and ignited. "Helicopter" or "aerial spinner" means a tube containing no more than twenty grams of chemical composition with a propeller or blade attached that spins rapidly as it rises into the air with a visible or audible effect sometimes produced at or near the height of flight.

"Hobbs" means the City of Hobbs, New Mexico.

"Illuminating torch" means a cylindrical tube containing no more than one hundred grams of pyrotechnic composition that produces a colored flame upon ignition and may be spiked, based or hand held. When more than one tube is mounted on a common base, total pyrotechnic composition shall not exceed two hundred grams.

"Manufacturer" means any person, firm or corporation engaged in the manufacture of fireworks.

<u>"Mine" or "Shell" means a heavy cardboard or paper tube usually attached to a</u> <u>wooden or plastic base and containing no more than sixty grams of total chemical</u> <u>composition, including lift charges, per tube that individually expels pellets of pressed</u> <u>pyrotechnic composition that burn with bright color in a star effect, or other devices</u> <u>propelled into the air, and that contains components producing reports containing a</u> <u>maximum one hundred thirty milligrams of explosive composition per report. A mine</u> <u>may contain more than one tube, but the tubes must fire in sequence upon ignition of</u> <u>one external fuse, must be a dense-packed collection of mine or shell tubes and the</u> <u>total chemical composition, including lift charges, shall not exceed two hundred grams.</u>

<u>"Missile-type rocket" means a device similar to a stick-type rocket in size,</u> <u>composition and effect that uses fins rather than a stick for guidance and stability and</u> that contains no more than twenty grams of chemical composition.

"Multiple tube devices" means a device that contains more than one cardboard tube and the ignition of one external fuse that causes all of the tubes to function in sequence. The tubes are individually attached to a wood or plastic base or are dense packed and are held together by glue, wire, string or other means that securely hold the tubes together during operation. A maximum total weight of five hundred grams of pyrotechnic composition shall be permitted; provided that the tubes are securely attached to a wood or plastic base and are separated from each other on the base by a distance of at least one-half inch. The connecting fuses on multiple tube devices shall be fused in sequence so that the tubes fire sequentially rather than all at once.

<u>"Novelties" means devices containing small amounts of pyrotechnic or explosive</u> composition that produce limited visible or audible effects, including party poppers, snappers, toy smoke devices, snakes, glowworms, sparklers or toy caps, and devices intended to produce unique visual or audible effects that contain sixteen milligrams or less of explosive composition and limited amounts of other pyrotechnic composition, including cigarette loads, trick matches, explosive auto alarms and other trick noisemakers.

"Permissible fireworks" or "consumer fireworks" means fireworks legal for sale and use in Hobbs under the provisions of the Hobbs fireworks ordinance.

Permissible fireworks are:

(1) ground and hand-held sparkling devices:

(a) cone fountains;

(b) crackling devices;

(c) cylindrical fountains;

(d) flitter sparklers;

(e) ground spinners;

(f) illuminating torches; and

(g) wheels.

"Non-Permissible fireworks" means fireworks not legal for sale and use in Hobbs under the provisions of the Hobbs fireworks ordinance.

Non-permissible fireworks are:

(1) aerial devices:

(a) aerial shell kit-reloadable tubes;

(b) aerial spinners;

(c) helicopters;

(d) mines;

(e) missile-type rockets;

(f) multiple tube devices;

(g) roman candles;

(h) shells; and

(i) stick-type rockets

(2) ground audible devices:

(a) chasers; and

(b) firecrackers.

"Retailer" means any person, firm or corporation purchasing fireworks for resale to consumers.

"Specialty retailer" means any person, firm or corporation purchasing <u>permissible</u> fireworks for year-round resale in permanent retail stores whose primary business is tourism.

<u>"Theatrical pyrotechnics articles" means a pyrotechnic device for professional use in</u> <u>the entertainment industry similar to permissible fireworks or consumer fireworks in</u> <u>chemical composition and construction but not intended and labeled for consumer use.</u>

"Wheel" means a pyrotechnic device that is made to attach to a post or other surface and that revolves, producing a shower of color and sparks and sometimes a whistling effect, and that may have one or more drivers, each of which contains no more than sixty grams of pyrotechnic composition and the total wheel contains no more than two hundred grams total pyrotechnic composition.

"Wholesaler" means any person, firm or corporation purchasing fireworks for <u>resale</u> <u>to</u> retailers.

(Ord. 874 (part), 2001; prior code § 10A-2)

8.12.030 - Permit required—Fee and issuance.

- A. No person may sell, hold for sale, import, distribute or offer for sale, <u>as manufacturer</u>, <u>distributor</u>, <u>wholesaler</u> or retailer, any fireworks in the City unless such person has first obtained the appropriate <u>license</u> or permit.
- B. The <u>Fire Chief or designee</u> shall enforce the Fireworks Licensing and Safety Act [60-2C-1 NMSA 1978]. The <u>Fire Chief or designee</u> shall enforce the Hobbs fireworks ordinance. All retailers shall be required to purchase a retail fireworks permit for each retail location. Permit applications shall be obtained from the City Clerk and submitted for approval to the office of the <u>Fire Chief or designee</u>. Upon receipt of an approved application, the City Clerk shall issue a permit.
- C. An applicant for a permit under the Hobbs fireworks ordinance shall pay to the City Clerk a fee of twenty-five dollars (\$25.00) which shall not be refundable or transferable.
- D. All permits shall be issued for one (1) year beginning on April 1st of each year. All permits shall be issued within thirty (30) days from the date of receipt of an approved application.
- E. Permits issued under the Hobbs fireworks ordinance shall not be restricted in number or limited to any person without cause.
- F. Any violation of the Hobbs fireworks ordinance may result in a revocation of any previously issued permit. Upon receipt of a notice of revocation of any previously issued permit, the permittee may appeal the revocation to the City Commission. The decision of the City Commission will be final. Upon a finding from the City Commission that the permittee violated the Hobbs fireworks ordinance, the permittee shall not be eligible to obtain a permit under the Hobbs fireworks ordinance until the April 1st immediately following the decision of the City Commission.

8.12.040 - Unauthorized/Illegal fireworks—Possession, sale or use unlawful.

No individual, property owner, or responsible party of listed property/event, firm, partnership, corporation or association shall possess for retail sale in Hobbs, sell or offer for sale at retail or use or possess any fireworks, including ground audible devices and aerial devices, other than permissible fireworks. <u>A recognized exception to this</u> section exists pursuant to Section 8.12.080 herein.

(Ord. 874 (part), 2001; prior code § 10A-4)

8.12.050 - Permissible fireworks.

"Permissible fireworks" for sale to the general public, as that term is used in the Hobbs fireworks ordinance, shall be understood to mean <u>consumer</u> fireworks legal for sale and use in New Mexico under the provisions of the <u>Fireworks Licensing and Safety Act [60-2C-1 NMSA 1978]</u>, as amended, with the exception of ground audible devices and aerial devices, which are prohibited pursuant to Section 8.12.040 of this chapter.

(Prior code § 10A-5)

8.12.060 - Retail sales and storage.

- A. No fireworks may be sold at retail without a retail permit. The permit shall be at the location where the retail sale takes place.
- B. It is unlawful to offer for sale or to sell any fireworks to children under the age of sixteen (16) years or to an intoxicated person.
- C. <u>All places where fireworks are stored, sold or displayed shall be in compliance with</u> the code of safety standards published by the national fire protection association for the manufacture, transportation, storage and retail sales of fireworks and pyrotechnics articles.
- D. At all places where fireworks are stored, sold or displayed, the words <u>"NO SMOKING"</u> shall be posted in letters at least four (4) inches in height. Smoking, <u>open flames and</u> <u>any ignition source are</u> prohibited within twenty-five (25) feet of any fireworks stock.
- E. No fireworks shall be stored, kept, sold or discharged within fifty (50) feet of a gasoline pump or gasoline bulk station or a building in which gasoline or volatile liquids are sold in quantities in excess of one (1) gallon, except in stores where cleaners, paints and oils are handled in sealed containers only.
- F. All fireworks permittees <u>and licensees</u> shall keep and maintain upon the premises a fire extinguisher bearing an Underwriters Laboratories Inc. rated capacity of at least five (5) pound ABC per five hundred (500) square feet of space used for fireworks sales or storage.
- G. <u>Sales clerks and ancillary personnel employed or volunteering at temporary retail</u> <u>locations where fireworks are sold shall be</u> at least sixteen (16) years of age. A sales clerk shall be on duty to serve consumers at the time of purchase or delivery. <u>Permissible</u> fireworks <u>may be offered for sale only at state-permitted or state-licensed</u> <u>retail locations in</u> Hobbs.
- H. No fireworks shall be discharged within one hundred fifty (150) feet of any fireworks retail sales location.
- I. No person shall ignite any fireworks within a motor vehicle or throw fireworks from a motor vehicle, nor shall any person place or throw any ignited article of fireworks into or at a motor vehicle or at or near any person or group of people.

- J. Any fireworks devices that are readily accessible to handling by consumers or purchasers in a retail sales location shall have their exposed fuses protected in a manner to protect against accidental ignition of an item by a spark, cigarette ash or other ignition source. If the fuse is a thread-wrapped safety fuse which has been coated with a <u>nonflammable</u> coating, only the outside end of the safety fuse shall be covered. If the fuse is not a safety fuse, then the entire fuse shall be covered.
- K. <u>Permissible</u> fireworks may be sold at retail between June 20th and July 6th of each year, six (6) days preceding and including new year's day, three (3) days preceding and including Chinese new year, the sixteenth of September and Cinco de Mayo of each year, except that permissible fireworks may be sold all year in permanent retail stores whose primary business is tourism.

(Ord. 874 (part), 2001; prior code § 10A-6)

- 8.12.070 Public display requirements.
- A. Any public display of fireworks shall require the individual, association, partnership, corporation or organization desiring to have such a display to secure a written permit from the office of the Fire Chief. The fireworks for such display shall be purchased from a distributor or display distributor licensed by the State Fire Marshal and the Bureau of Alcohol, Tobacco and Firearms at the United States Department of the Treasury.
- B. The <u>Fire Chief or designee</u> may adopt reasonable rules and regulations for the use of fireworks in public displays.

(Prior code § 10A-7)

8.12.080 - Safe Zones established.

The City of Hobbs shall designate "Safe Zones" and times for unauthorized/illegal firework displays. At least ten calendar days prior to the dates outlined in Section 8.12.060(K), the City of Hobbs shall furnish to the public the location of the designated Safe Zones. Unauthorized/Illegal fireworks are not permitted within the municipal boundaries of Hobbs, New Mexico, unless said unauthorized/illegal fireworks are possessed and displayed in City of Hobbs designated Safe Zones. If unauthorized/illegal fireworks are possessed and or displayed in places other than the designated Safe Zones, the individual, property owner, or responsible party of listed property/event, firm, partnership or corporation is in violation of the Hobbs fireworks Ordinance and are subject to the penalties set forth in Section 8.12.090 and Section 8.12.100.

8.12.090 - Violation—Penalty—Criminal Petty Misdemeanor.

Any individual, <u>property owner</u>, or <u>responsible party of listed property/event</u>, firm, partnership or corporation that violates any provision of the Hobbs fireworks ordinance shall be given the opportunity to surrender their illegal fireworks for destruction in lieu of

<u>a citation. If any individual, property owner, or responsible party of listed property/event, firm, partnership or corporation refuses to surrender the illegal fireworks, they will be issued a citation for violation of the Hobbs fireworks ordinance. Upon conviction, the offender shall be punished by a fine of not more than five hundred dollars (\$500.00) or by imprisonment for not more than ninety (90) days, or by both such fine and imprisonment.</u>

(Prior code § 10A-8)

8.12.100 - Violations-Penalty-Civil.


- A. Addresses that have been identified as locations where illegal fireworks are used will be issued a Cease and Desist order by certified mail. A Cease and Desist Order is a document that serves as official notice that the owner and/or occupant (responsible party of listed property/event) has been found to be in violation the Hobbs fireworks Ordinance. Any Cease and Desist Order issued within a given calendar year may be used as evidence in any subsequent criminal prosecution and may serve as prima facie evidence against the issuance of any future permits under the Hobbs fireworks ordinance.
- B. If an <u>individual</u>, <u>property owner</u>, <u>or responsible party of listed property/event</u> is found guilty of violating any of the provisions of the Hobbs fireworks ordinance, that person's permit may be revoked or suspended by the Fire Chief, his or her deputies or designee <u>as contemplated by Section 8.12.030(F) above</u>.
- C. No individual, firm, corporation or partnership shall possess any fireworks for sale within the city limits of Hobbs, <u>New Mexico</u> other than those authorized in the Hobbs fireworks ordinance. The Fire Chief, his or her deputies or designee may at reasonable hours enter and inspect the permittee's premises to determine compliance with the Hobbs fireworks ordinance. If any retailer has in his or her possession any fireworks in violation of that <u>ordinance</u>, his or her permit shall be revoked and all such fireworks seized, and the fireworks shall be kept to be used as evidence. If any person has in his or her possession any fireworks and the fireworks and the fireworks and the fireworks shall be safely kept to be used as evidence. Upon conviction of the offender, the fireworks shall be destroyed, but if the offender is discharged, the permissible fireworks shall be returned to the person in whose possession they were found.

YES Housing, Inc. has proposed to finance and develop a 56 unit affordable senior housing Summary: complex on developer controlled property located northeast of the corner of Berry and Grimes. The project will be restricted to seniors with all of the proposed units income and rent restricted to 60% or below area median income.

The projects Total Development Cost is anticipated to be +/-\$14,250,000.00 so a local contribution of 10% of TDC would earn the Developer 10 points in scoring toward LIHTC funding. Municipal Code Chapter 3.14 allows the City to extend financial incentives to stimulate the development and construction of Affordable Senior Housing projects for multi-family housing. In order to qualify, the project must be considered as an Affordable Housing Project according to the City's Affordable Housing Plan. The Project must also be approved and funded by the NMMFA and comply with State MFA rules.

The Resolution proposes that the City make a conditional offer of financial assistance in an amount not to exceed \$1,425,000, to include waiver of development fees to YES Housing, Inc. if the proposed project is funded by the state and developed. The Letter of Financial Support gives approval to the Project and commits the funding, contingent on the Developer receiving an allocation of LIHTC's during the 2021 cycle.

Total unencumbered Affordable Housing Budget is \$1,145,429.00. A budget reclassification in the amount of \$300,000.00 from 01-0410-44901-00160 to 010100-44901-00169 would need to be made in Bar #3 and submitted to DFA for approval in January 2021.

This resolution will cause the City to incur a maximum expense as reflected above for the development of this Affordable Senior Housing project in fund 01-0100-44901-00169, if the application is funded by NMMFA.








Hobbs, West Berry Preliminary Building Floor Plan (level 1)



A RESOLUTION DETERMINING THAT CERTAIN STRUCTURES ARE RUINED, DAMAGED AND DILAPIDATED, ARE A MENACE TO PUBLIC COMFORT, HEALTH AND SAFETY AND REQUIRES REMOVAL FROM THE MUNICIPALITY

WHEREAS, pursuant to Section 8.24.010 of the Hobbs Municipal Code, and Section 3-18-5 NMSA, as amended, the City has inspected the premises described in Attachment "A", attached hereto and incorporated herein by reference, and finds that the structures thereon are ruined, damaged and dilapidated, are a menace to the public comfort, health and safety and requires removal from the municipality.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF HOBBS, NEW MEXICO, that the structures described in Attachment "A" are found to be ruined, damaged and dilapidated, are a menace to the public comfort, health and safety, and should be removed.

BE IT FURTHER RESOLVED that a copy of this Resolution be served on the owner, occupant or agent in charge of such premises; or, if such service cannot be had, that a copy of this Resolution be posted on the premises; and that a copy of the same be published as required by law.

BE IT FURTHER RESOLVED that unless the owner, occupant or agent in charge of such premises, within ten (10) days from such service or posting and publication of this Resolution, has commenced removing such structures from the real property or has filed written objection with the City, the City shall cause the removal of such structures at the cost and expense of the property owner.

BE IT FURTHER RESOLVED that in cases where the City removes a structure so condemned, a lien shall be levied by the City against the real property involved in an amount equal to the reasonable cost of the services rendered, which lien may be foreclosed in default of satisfaction.










LOT EAST OF 213 E. WHITE
